IF THIS HAPPENS	DO THIS
Vehicle accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Prevent migration into the environment - onto adjacent land or into waterways. Lightly mist unrecoverable product with water and sweep or scrape up. Wear protective equipment including eye protection to avoid exposure. Large spills due to traffic accidents, etc., should be reported immediately to CHEMCALL and NZTA for assistance.
Fire	Call the Fire Service: Dial 111. May emit toxic fumes when exposed to heat.

FIRST AID

If swallowed	If product is swallowed, do NOT induce vomiting. Contact a Poisons Information Centre / doctor immediately.
If in eyes	If splashed in eyes, hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention immediately.
If on skin	If skin or hair contact occurs thoroughly wash affected areas with soap and water.
If inhaled	Remove patient to fresh air. Get medical attention if breathing difficulty develops.

STORAGE AND SEGREGATION
